## FINANCIAL OBLIGATION POLICY

Vitality Physical Therapy, LLC is not a preferred provider for any insurance company. Instead, we provide physical therapy on a “fee at time of service” basis. By removing ourselves from a preferred provider/contracted status with the insurance companies, we do not have to limit the time or quality of treatment we provide because of insurance company restrictions or elevate our rates to pay for billing services. Additionally, we have the flexibility to assist patients in financial need. Please contact VPT Admin for sliding scale details.

Secondary to Medicare rules, as a *Non-participating Medicare Provider*, we do not have a Medicare number you can use to submit to Medicare for reimbursement. Additionally, due to the mandatory claims submission rule, Medicare patients are not able to pay cash out-of-pocket for otherwise covered Medicare physical therapy services provided by a *Non-participating Medicare Provider*. We sincerely apologize for any inconvenience.

Prior to your first scheduled appointment, it is highly recommended you call your insurance company to completely understand your out-of-network physical therapy benefits. An insurance company worksheet is available on [www.VitalityPT.org](http://www.VitalityPT.org) to help you ask the insurance company the right questions about your physical therapy benefits.

At the time of service and payment, you will receive an electronic statement which you can submit to your insurance company for their consideration of reimbursement directly to you. We will be happy to provide chart notes or other documentation at your—or your insurance company’s—request. The amount of reimbursement you receive will vary according to the terms of your insurance policy. Some companies may reimburse you at 80%, some at 60%, some at 40%, and some may not reimburse you at all. We cannot make guarantees or estimates regarding what reimbursement your plan allows.
